Raffle Rules

1. Tickets may be purchased only by residents of Texas, who are U.S. citizens age 18 or over, who are eligible to legally own a firearm according to all U.S. Federal and Texas State laws.
2. By purchasing a raffle ticket, purchasers attest to being a law-abiding, legal citizen of the United States, of good moral character, who may legally possess any firearm won, agree to use the firearm only in a legal and safe manner, and will or have already obtained instruction on the safe use and operation of the firearm won.
3. Prizes are not transferable. The person designated on the ticket is the only person who can claim the prize and may be required to show a valid photo identification to claim the prize.
4. There is no limit to the number of tickets any eligible individual may purchase. Ticket stubs must bear the name of one purchaser only.
5. The cost of each ticket is \$50.
6. Maximum tickets available to be sold - 475.
7. The prizes will be awarded in order listed on the ticket.
8. The last day to purchase tickets online is September 14.
9. A drawing will take place on Saturday, September 16, 2017, at 7:00 p.m. The Den restaurant, 484 Bluebonnet Dr., La Vernia.
10. Winners need not be present to win.
11. Winners will be contacted by the LVHA as soon as possible.
12. All prizes must be claimed within seven days of the drawing.
13. Unclaimed prizes become the property of the LVHA.
14. Winners are eligible only for the specific item being drawn.
15. Proceeds from the raffle benefit the La Vernia Veterans Memorial, a project of the La Vernia Historical Association (LVHA), a non-profit 501(c)3 nonprofit charity organization.

16. All Federal Bureau of Tobacco and Firearms rules apply, and by claiming a firearm prize winner agrees to provide all information necessary for the transfer of the firearm won.
17. Transfer will be done only through Tyson Stephens, a Federal Firearms Licensed (FFL) Dealer. All applicable Federal and State laws will apply, including the state laws for the legal residence of winning ticket holder.
18. If winner is not able to pass FFL Regulations, the winner will forfeit any and all rights to the prize.
19. Winners will be responsible for any applicable Federal, State and local taxes as pertains to prize winnings, if applicable.
20. Winners may be required to verify that ownership of the firearm won is legal in their state, city, or town prior to taking possession of the prize.
21. LVHA limits any and all liability to the purchase price of the ticket purchased.
22. Information obtained on raffle tickets is for the use of LVHA only.
23. Winners have the option of permitting publicity releases for photos and information to be used in social media and print publications as released by the LVHA. Authorization for publicity must be in writing.
24. Firearms are the property of the Dealer until legally delivered to the eligible winner.
25. At no time is the LVHA the owner of any firearms in the raffle.
26. Results of the drawings are final.
